CUSTOM CLEARING DATA : Documents required in the Hellenic Customs **for Exhibitors outside the European Union (EU)**:

a. Either the International Document CARNET ATA issued by the Chamber of Commerce and Industry of the Countries which belong in the CARNET ATA system (in such a case there is no any V.A.T or import tax) **or**

b. Invoice with detail description and values (in EURO or in US \$) of the various items + Certificate of Origin signed by the Chamber of Commerce and Industry in the Exhibitor's Country. (In such a case there is a 21% V.A.T. on import based on total amount in the Invoice accompanied the merchandise to be imported).

-If the quantity of the items is substantial , it is advised that the products be splitted into small different parcels instead of a big one. In such a case each parcel will be accompanied by its own Invoice and Certificate of Origin or CARNET ATA.

-Overseas participants are advised to arrive in Athens NOT later than 24 November 2010 for Custom Clearing or arrange to have their items Customs Cleared well before 26 November 2010.

-It is advised that Exhibitors outside the European Union , arrange to complete ENTRY not later than 26 August 2010 and apply timely for VISA in the Hellenic Embassy or the Hellenic Consulate in their Country, or the nearest Hellenic Embassy in charge.

-It is also advised that the Exhibitors outside the European Union, arrange to send their items in Athens by a major International Forwarder and Custom Clearing Agent.
